Instructions for Completing the EWU Gender, Women's & Sexuality Studies Affiliated Faculty Agreement:

Faculty will indicate the five-year period for GWSS affiliated faculty on the Agreement Form in the first sentence. For example: Fall 2016-Spring 2021.

Faculty members will compete **at least two of the items** on the template designating how they will satisfy **two of the four criteria** listed on the application by filling in the blanks under those criteria on the agreement. Faculty may omit those paragraphs that are not relevant to their agreement.

*Faculty only need to complete the fourth item referring to other criteria or activities approved by the GWSS program committee if they do not satisfy at least two of the first three criteria listed.

The four possible criteria are:

- 1) Teaching or co-teaching one or more courses cross-listed with Gender, Women's & Sexuality Studies at least once every three years at EWU.
- 2) Regular participation in Gender, Women's & Sexuality Studies committees and/or curriculum development in Gender, Women's & Sexuality Studies at EWU at least five quarters within the five- year agreement period.
- 3) Engaging in scholarly research on women, Gender, Women's & Sexuality Studies, women's issues, gender, sexuality, feminism, feminist theory or the advancement of women in their discipline or profession.
- 4) Other criteria as determined by the faculty member and director of Gender, Women's & Sexuality Studies, pending approval of the Gender, Women's & Sexuality Studies program committee.

The agreement and application are subject to approval by the Gender, Women's & Sexuality Studies program committee and the GWSS director. If the Gender, Women's & Sexuality Studies affiliated faculty application and agreement or renewal are approved, the faculty member will be notified and will then obtain the signature of their department chair and return the signed agreement to the Gender, Women's & Sexuality Studies.
