We are developing a standard syllabus template to be implemented this year as part as a campus-wide initiative. Additionally, the university is hiring an assessment director to better help the entire campus academic departments to better align and assess student learning outcomes.

We have been moved into Outreach and Engagement under Academic Affairs. My direct report is now the Associate Vice Provost. We have had 3 new faculty coordinators, and increase our program size by over 10% including instructors, high schools, and instructors. We also had a new hire in the concurrent enrollment program, operations manager.
